Our constant goal is to provide you with a safe and dependable supply of drinking water. The Utility wants you to understand the efforts we make to continually improve the water treatment process and protect our water resources. The Town of Lake Placid is committed to ensuring the quality of your water

Our water source is from ground water wells. The two wells draw from the deep Floridian Aquifer and the water is treated with chlorine for the purpose of disinfection.

This report shows our water quality results as well as terms and/or abbreviations and what they mean.

The Town of Lake Placid routinely monitors for contaminants in your drinking water according to Federal and State laws, rules, and regulations. Except where indicated otherwise, this report is based on the results of our monitoring for the period of January 1 to December 31, 2022. Data obtained before January 1, 2023, and presented in this report are from the most recent testing done in accordance with the laws, rules, and regulations.

Terms and Abbreviations

In the following tables (bottom of this page and the next), you may find unfamiliar terms and abbreviations. To help you better understand these terms we have provided the following definitions:

Action Level (AL): The concentration of a contaminant, which, if exceeded, triggers treatment, or other requirements that a water system must follow. "ND" means *not detected* and indicates that the substance was not found by laboratory analysis.

Maximum Contaminant Level or MCL: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or MCLG: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MRDL stands for Maximum Residual Disinfectant Limit. MRDL means the maximum level of a disinfectant added for water treatment that may not be exceeded.

MRDLG stands for Maximum residual disinfection level goal. The level or a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Parts per million (ppm) or Milligrams per liter (mg/l): One (1) part by weight of analyte to one (1) million parts by weight of the water sample.

Parts per billion (ppb) or Micrograms per liter (\mu g/l): One (1) part by weight of analyte to one (1) billion parts by weight of the water sample.

Picocurie per liter (pCi/L): Measure of the radioactivity in water.

Monitoring of Lead in Drinking Water:

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Town of Lake Placid Utilities Department is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Sources of water:

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include the following:

- (A) *Microbial contaminants*, such as viruses and bacteria, which may come from wastewater treatment plants, septic systems, agricultural livestock operations, and wildlife.
- (B) *Inorganic contaminants*, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm waterrunoff, and residential uses.
- (D) *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can, also, come from vehicle gas stations, urban storm water runoff, and septic systems.
- (E) Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the (Federal) Environmental Protection Agency (EPA) prescribes regulations, which limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immune-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These citizens should seek advice about drinking water from their health care providers. The Town does not contract out the operations of our facilities as we have full time employed state certified treatment plant operators on staff who monitor our systems to ensure the absolute best quality of drinking water.

In our continuing effort to maintain a safe and dependable water supply, it may be necessary, from time to time, to make improvements in our public water system. The costs of these improvements may sometimes be reflected in the rate structure. Rate adjustments could be necessary in order to address these improvements. Thank you for your understanding in this matter of great importance to the health and wellbeing of our customers.

We ask that all our customers help us protect our water resources, which are the heart of our community, our way of life and our children's future.
